4.0 Discussion/Approval to Adopt Ordinance 2018-06 Authorizing the Town of Estancia to Opt In the Election of its Municipal Officers in the Regular Local Election- Action Item

There was discussion among the Trustees and members of the audience about whether to lengthen or shorten the current elected official's terms to align with the odd year November elections. Terms will either be lengthened by 1 year and 10 months or shortened by 9 weeks. After some discussion the Board decided to adopt the Ordinance to Opt- In and agreed to shorten their terms by 9 weeks. **ACTION TAKEN:** Trustee Romero made a motion to approve Ordinance 2018-06 Authorizing the Town of Estancia to Opt In the Election of its Municipal Officers in the regular local election and to reduce the current terms by 9 weeks to align with the odd year November elections. Trustee Hall seconded the motion. All in favor. Roll Call Vote: Trustee Romero-yes, Trustee Sedillo- absent, Trustee Chavez- yes, Trustee Hall –yes **MOTION CARRIED**

5.0 Approval of Proclamation Proclaiming September Suicide Awareness Month- Action Item
Mayor Dial presented the Town of Estancia Proclamation proclaiming September Suicide Awareness Month. **ACTION TAKEN:** Trustee Hall made a motion to approve the Proclamation. Trustee Chavez seconded the motion. All in favor. **MOTION CARRIED**

6.0 Discussion/Approval of Capital Outlay Agreement, Resolution 2018-20, and Fiscal Agent MOU- Action Item
Clerk Michelle Jones explained that these documents need to be approved to move forward with obtaining \$20,000.00 in Capital Outlay money to help improve our wells. **ACTION TAKEN:** Trustee Hall made a motion to approve the Capital Outlay Agreement, Resolution 2018-20 and the Fiscal Agent MOU with the MRCOG. Trustee Chavez seconded the motion. Roll Call Vote: Trustee Romero-yes, Trustee Sedillo- absent, Trustee Chavez- yes, Trustee Hall –yes **MOTION CARRIED**

7.0 Mayor/Council:

Trustee Hall said that he is still working on amendments to Chapter 9 of the Town Ordinances. He also said that he recently attended an EVEDA meeting and many good things are coming. He gave the Clerk a hand-out which listed EVEDA’s client activity.

Trustee Chavez said she will work on getting a crew together to run the Town’s chunker for Punkin Chunkin. She asked that the Public Works Department clean out the trash cans on Main Street.
