TOWN OF ESTANCIA

PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM AND REQUEST FOR MATCH WAIVER
ADMINISTERED
BY NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS, the Town of Estancia and the New Mexico Department of Transportation enter into a
Cooperative Agreement.

WHEREAS, the total cost of the project will be \$66,667.00 to be funded in proportional share by the
parties hereto as follows:

a. New Mexico Department of Transportation's share shall be 75% or \$50,000.00

and

b. The Town of Estancia's proportional matching share shall be 25% or \$16,667.00 if Hardship for
Match Waiver is not deemed to be present by Department of Finance and Administration and the
Department of Transportation

TOTAL PROJECT COST IS \$66,667.00

The Town of Estancia shall pay all costs, which exceed the total amount of \$66,667.00.

WHEREAS, the Town of Estancia has a limited tax base, which limits the funding for meeting the
proportional matching share; and, a fund exists in the NMDOT appropriated by the New Mexico State Legislature
for Public Entities in need of "hardship" match money and the Town of Estancia requests participation in this
Match Waiver Program in the amount of \$66,667.00.


Now therefore, be it resolved in official session that the Town of Estancia determines, resolves, and
orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on **December 31, 2021** and the Town of Estancia incorporates all the
agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and
all such covenants, agreements and understandings have been merged into the written agreement.

NOW therefore, be it resolved by the Town of Estancia to enter into Cooperative Agreement Control Number L500397 with the New Mexico Department of Transportation for LGRF Project for year 2020 - 2021 to planning, design, drainage improvements, pavement rehabilitation/improvements, construction, reconstruction, sidewalk, resurfacing, construction management and miscellaneous improvements to Highland Avenue between NMSR 41 to the Senior Center within the control of the Town of Estancia in Torrance County, New Mexico.

The Town of Estancia is interested in applying for the LGRF Hardship Match Waiver per the NM Administrative Code 18 NMAC 27.3.8 for our pending funding through the FY 20/21 LGRF program.


NMAC 27.3.8 allows Public Entities who are experiencing financial hardship to apply for a Match Waiver of all or part of the Public Entity match normally required for participation in the Local Government Road Fund.

The Town of Estancia qualifies for the Match Waiver due to having a limited tax base which limits the funding for meeting the proportional matching share.

The Town of Estancia requests a Match Waiver in the amount of \$16,667.00 for the LGRF Project for year 2020 – 2021 for the planning, design, drainage improvements, pavement rehabilitation/improvements, construction, reconstruction, sidewalk, resurfacing, construction management and miscellaneous improvements of Gaston Street between Spurr Avenue and James Avenue, Gaston Street and Leonard Avenue intersection, Highland Avenue between 4th Street & end of road (at the gate), 10th Street between Highland Avenue and Williams Avenue, Hopewell Avenue between 5th Street & 7th Street, and Lassiter Street between Spurr Avenue and Alan Ayers; within the control of the Town of Estancia in Torrance County, New Mexico.
