#### **Minutes**

Invocation and Pledge of Allegiance

The meeting was called to order at 6:15 pm and Roll Call was taken:

- 4.0 Discussion/Approval of April 16, 2018 Bill List Action Item
  Trustee Sedillo asked about a purchase from Barnes and Noble. He was informed that this was a purchase for the Library. ACTION TAKEN: Trustee Romero made a motion to approve the April 16, 2018 Bill List. Trustee Chavez seconded the motion. All in favor. MOTION CARRIED

Our Public Works Supervisor, Lorenzo Bernal will be given the list to work on at his convenience. Mr. Hall is sincerely thanked for his volunteer work at the airport. Mr. Hall will also meet with the Mr. Bernal to discuss the recommendations.

Clerk Michelle Jones informed the Board that she has successfully completed her Certified Procurement Officer Training. She thanked the Board for sending her to the training.

Ms. Sylvia Chavez, resident and prior Mayor to the Town of Estancia, addressed the Board and current Mayor Dial. She thanked them for re-appointing her to the EMW Gas board. She said that she would be reporting regularly to the Board about EMW Gas Board activities.

Ms. Jeanette Hunt thanked the Board for their work to raise funds to operate the pool this coming summer. She has started a Go Fund Me page to help raise money for the pool and has currently raised about \$500.00. She asked about the proper way to bring the funds to the Town when she finishes her fund raiser. The Clerk suggested that she present a check for the funds at a Board of Trustees Open meeting.

The Clerk and Deputy Clerk told the Board that we would be accepting applications for a Pool Manager and Lifeguards until end of day on April 26<sup>th</sup> and then will schedule interviews. We will reach out to the different entities to make sure they know that we are taking applications. We will also ask about suggestions for pool hours of operation.

## 7.0 Discussion of possible dedication of land in front of Old Sturges Market-Possible Action Item

- 10.0 Discussion/Approval of Volunteer for Animal Control Action Item
  Police Chief Stephanie Reynolds asked for approval for Colin Milbourne to volunteer at the
  Town's Animal Shelter. Colin is also a Volunteer Fire Fighter with the Town. ACTION
  TAKEN: Trustee Chavez made a motion to approve Colin Milbourne to work as a volunteer for
  the Town at our Animal Shelter. Trustee Hall seconded the motion. All in favor. MOTION
  CARRIED

#### 11.0 Mayor/Council:

Trustee Hall commented about Berkshire Road. He said that it is eroding must be maintained in useable condition. He also talked about 10<sup>th</sup> Street out to the Transfer Station. He requested that Mr. Bernal look at these roads and get with the County, if necessary, to see if anything can be done to get them in better condition.

Trustee Chavez asked if Municipal Judge Dial had any program for kids. Chief Reynolds replied yes and talked about Teen Court and the Juvenile Justice Board. She also asked that everyone keep an open mind with regards to suggestions about the pool.

**Trustee Sedillo** also asked that everyone keep an open mind about the pool. He said that we need to focus on getting the pool fixed and the kids hired. He also asked about how the pond is stocked. He had some suggestions and was directed to call Game and Fish.

**Trustee Romero** said that he was very happy that we were moving forward with getting the road in front of Sturges and the Post Office taken care of.

Mayor Dial said that the movie being filmed right outside of Estancia seemed to be moving forward, as well as the solar array project. He said that we were only providing water to the solar array project on an emergency basis in order to insure water for our residents.

Mayor Dial said that a plaque for Officer Smith was being donated by the school. The Clerk's Office asked for donations from the Board and the Mayor for a plaque for our prior Public Works Supervisor, George Chavez, who worked for the Town for 23 years. Ms. Jones will be collecting the money and getting the plaque made.

Mayor Dial is taking care of replacing the flags at the Estancia Veteran's Plaza. He also said that, going forward, we would be giving the invocation before the Pledge; God and Country.
