# **Minutes**

The meeting was called to order at 5:45 pm and Roll Call was taken:

# 1.0 Approval/Disapproval of Agenda – Action Item

**ACTION TAKEN:** Trustee Hall made a motion to approve the agenda as written. Trustee Chavez seconded the motion. All in favor. **MOTION CARRIED** 

### 2.0 Rate and select an auditor for the FY18 Audit- Action Item

Clerk Michelle Jones informed the Board and the Mayor that we had received two responses to our RFP for an Auditor for our FY18 Audit. We received a proposal from Beasley, Mitchell & Co. and a proposal from Kubiak, Melton, & Associates, LLC.

Ms. Jones presented the proposal packets from both firms to the Board members and the Mayor. She also gave each of them a scoring sheet to rate each firm. The grand totals are listed here:

**ACTION TAKEN:** Trustee Hall made a motion to select Kubiak, Melton, & Associates to conduct out FY 18 audit. Trustee Romero seconded the motion. All in favor. **MOTION CARRIED** 

Ms. Jones will submit Kubiak, Melton, & Associates as our firm of choice to the Office of the State Auditor. There will be an option to renew with this firm for three consecutive years.

3.0 Schedule interview times for the pool lifeguard and supervisor candidates- Action Item
Clerk Michelle Jones told the Board that the time for accepting applications ended at the end of
business on 4/26. We received 9 applications for Pool Manager and 48 applications for
Lifeguards. We will give the applications an initial review and then schedule interviews this
coming week. Trustee Hall will not be available to conduct interviews. Trustee Chavez will ask
Josie Chavez to conduct interviews in her place. Trustee Sedillo will also not be available. Clerk
Michelle Jones will conduct interviews in place of Trustee Hall and Deputy Clerk Michelle
Dunlap will conduct interviews in place of Trustee Sedillo. Trustee Romero will attend the
interviews. We will have 4 representatives to conduct interviews. ACTION TAKEN: Trustee
Sedillo makes a motion to conduct interviews next week with the representatives as listed above.
Trustee Romero seconds the motion. All in favor. MOTION CARRIED

Trustee Hall asked that an item be put on the next regular meeting agenda to discuss Mr. Sturges dedicating the road in front of the old grocery store and Post Office to the Town. Trustee Romero asked that an item be put on the next agenda to discuss nominating Ms. Michelle Jones for Clerk of the Year. Trustee Romero commended Mayor Dial for his comments at the recent EVSWA Board meeting. Mayor Dial has requested that the EVSWA Board consider contributing funds to help run the pool, Lastly, Mayor Dial asked that the Town check and see if we can have a DPS (Department of Public Safety) which could allow us to have access to more federal funding. Deputy Clerk Michelle Dunlap will contact our old Fire Chief Lester Gary to see what he knows about this.
