4.0 Approval of Proclamation Declaring May 11-17, 2022 as National Police Week in the Town of Estancia- Action Item Trustee Lovato read the following Proclamation into the record:

Town of Estancia
Board of Trustees

DESIGNATE May 11-17, 2022 AS

"National Police Week"

To recognize National Police Week 2022 and to honor the service and sacrifice of those law enforcement officers killed in the line of duty while protecting our communities and safeguarding our democracy.

WHEREAS, there are more than 800,000 law enforcement officers serving in communities across the United States, including the dedicated members of the Town of Estancia Police Department; and

WHEREAS, since the first recorded death in 1786, more than 23,000 law enforcement officers in the United States have made the ultimate sacrifice and been killed in the line of duty; and

WHEREAS, the names of these dedicated public servants are engraved on the walls of the National Law Enforcement Officers Memorial in Washington, DC; and

WHEREAS, 619 new names of fallen heroes are being added to the National Law Enforcement Officers Memorial this spring, including 472 officers killed in 2021 and 147 officers killed in previous years; and

WHEREAS, the service and sacrifice of all officers killed in the line of duty will be honored during the National Law Enforcement Officers Memorial Fund's 34th Candlelight Vigil, on the evening of May 13, 2022; and

WHEREAS, the Candlelight Vigil is part of National Police Week, which will be observed this year May 11-17; and

WHEREAS, May 15 is designated as Peace Officers Memorial Day, in honor of all fallen officers and their families and U.S. flags should be flown at half-staff;

THEREFORE, BE IT RESOLVED that the Board of Trustees of the Town of Estancia will observe May 11-17, 2022, as National Police Week and publicly salutes the service of law enforcement officers in our community and in communities across the nation.

Ms. Jones said many factors are contributing to the strong financials for the Town. Gross Receipts Taxes continue to be very strong and we have Capital Outlay funding and American Recovery Act funding that we did not spend this year, along with the revenue we received from the Tax and Rev lawsuit. All this funding will roll to the new fiscal year and can be discussed in detail during the budget workshop. NO ACTION, INFORMATION ONLY.

- Information about the Pool Opening Information Only Clerk Michelle Jones told that Board that we 10.0 are working very hard to try to get the pool open for the public by June 14th. We have hired our crew and are now working with the Mayor and the Public Works department to get the pool ready. Utility Billing Clerk Laura Acosta has taken over the responsibility of working with the Lifeguards and the Pool Supervisor to ensure that they all become certified, and drug tested. She is ordering all the needed supplies, etc. Ms. Jones will update the Board at every meeting until the pool opens. NO ACTION, INFORMATION **ONLY**

She suggested asking resident Jeff Brock if he might be interested in painting something fun there- maybe the home of the barracudas or come up with a logo for the Estancia Aquatic Center. Mayor Pro-tem Sedillo will ask him. She also talked about a culvert in town that is a hazard.

Mayor Pro-tem Sedillo thanked the PD for all their efforts on behalf of the town.

Trustee Lovato requested that we try to get port-a-potties for the park for the whole summer, not just for holidays and special events. Ms. Jones will work on this. He also said he is very excited that the fairgrounds have sold and we can start thinking about the baseball field.
