Trustee Lovato – Present Trustee Sedillo – Absent Trustee Chavez – Absent Trustee Hall – Present Mayor Dial – Present



- 2.0 Approval of the November 7, 2022 Regular Meeting minutes Action Item ACTION TAKEN: Trustee Hall made a motion to approve the November 7, 2022 Regular Meeting minutes as written. Trustee Lovato seconded the motion. All in favor. MOTION CARRIED
- 3.0 Discussion/Approval of the November 21, 2022 Bill List Action Item
 ACTION TAKEN: Trustee Lovato made a motion to approve the November 21, 2022 Bill List. Trustee Hall seconded the motion. All in favor. MOTION CARRIED

Public Comment – Resident Tracey Master addressed the Board. She told them about an incident that had occurred on the morning of November 10. She said there had been a fatal traffic accident and one person had been killed and two others had been injured. She said she had visited the home of kids who had lost their dad in the accident. She said it was a very volatile situation and one of our EMS/Fire volunteers Linda Gutierrez was there and was amazing. She exhibited so much kindness and understanding; she was wonderful. Ms. Master said that the Superior paramedics who also showed up there were horrible and their treatment of the children was inexcusable. A formal complaint against Superior has been made. Ms. Master's main message was about Linda, who went above and beyond and was an outstanding example of professionalism, compassion, and understanding. The Board thanked Ms. Master sincerely for her time and her comments. Ms. Gutierrez is thanked for her continued outstanding work and commitment on behalf of the Town.

New Business

- 5.0 Approval of Professional Services agreement for assistance from Rural Water - Action Item Mayor Dial told the Board that the Town can contract with someone from Rural Water to help us with our compliance and sending our monthly samples and training our current PW employees for \$1500.00 per month. ACTION TAKEN: Trustee Hall made a motion to approve entering into a Professional Services agreement with Rural Water to get assistance with water sampling, compliance, and training for no more than \$1500.00 per month. Trustee Lovato seconded the motion. All in favor. MOTION CARRIED
- Approval of hiring of Davaya Lucero to the position of Part-Time Youth Library Aid- Action Item 6.0 Clerk Jones told the Board that three candidates had been interviewed at the Library and Ms. Davaya Lucero scored the highest as was recommended for hire beginning December 5, 2022 with a starting salary of \$12.50 per hour. ACTION TAKEN: Trustee Lovato made a motion to approve the hiring of Davaya Lucero to the position of Part-time Youth Library Aid. Trustee Hall seconded the motion. All in favor. **MOTION CARRIED**
