## No Old Business New Business

- 4.0 Discussion and approval of annual contract with Envision IT for IT services- Action Item
  The Board reviewed the proposed contract and asked for Legal review before proceeding any further.
  ACTION TAKEN: Trustee Lovato made a motion to TABLE this item. Trustee Sedillo seconded the motion.
  All in favor. ITEM TABLED
- Approve contract with Mr. Steven Ferguson from Wildlife, Fisheries, and Habitat Services LLC for Pond Services- Action Item Mr. Ferguson presented his annual contract for pond services. This contract is the same as last year; Mr. Ferguson did not raise his prices. The Board is happy to renew his contract. ACTION TAKEN: Trustee Sedillo made a motion to approve the contract with Mr. Steven Ferguson from Wildlife, Fisheries, and Habitat Services LLC for Pond Services. Trustee Lovato seconded the motion. All in favor. MOTION CARRIED
- Discuss proposal for Fire/EMT staff positions- Discussion/Possible Action 6.0 Volunteer Fire Chief Chris Wolonsky and Volunteer Fire/EMT Jonathan Barela addressed the Board. They, along with the Mayor, are proposing the following: Chief Wolonsky, under the direction of the Mayor, would directly supervise the volunteer firefighters. EMT Jonathan Barela, under the direction of the Mayor, would be appointed to the new position of EMT Chief and would directly supervise the full-time and volunteer EMTs. Mr. Barela would receive a monthly stipend in the same amount that the Volunteer Fire Chief is receiving now. The starting pay for the EMT's would be \$18.75 and hour. EMT job descriptions have already been reviewed and established. Trustee Sedillo said he would like to see a compensation schedule, an organization chart, a list of job duties and a review by Legal. The information Trustee Sedillo was requesting was not readily available. Chief Wolonsky said that if we did not more quickly, our EMT candidates might not be available for hire when we were ready to move forward. Chief Wolonsky said that he did not have time to accomplish everything that Trustee Sedillo was asking for and said, in summary, that he was very close to quitting. Trustee Sedillo said, in summary, that maybe that he should do that. Chief Wolonsky told Mr. Barela that he would be giving him his keys, etc. and left the meeting. The Board decided to TABLE this item and call a Special Meeting to discuss this item further; tabling would allow time to gather the information that Trustee Sedillo was requesting, and a Special Meeting would allow for more expeditious action to be taken. ACTION TAKEN: Trustee Lovato made a motion to TABLE this item and call a Special Meeting for Monday, February 27, 2023 to allow for legal review and more research to be conducted on this item. Trustee Hall seconded the motion. All in favor. ITEM TABLED
- Review letter of Interest for EMWT representative- Possible Action
  Resident David Talley submitted a letter of interest to represent the town on the EMWT Board. He attended the meeting and answered questions from the Board. Mr. Talley said that he lived in Estancia and that his priority, if appointed to this Board, would be to safeguard the water for this town and the Estancia Valley. Mayor Dial appointed Mr. Talley to the EMWT Board. ACTION TAKEN: Trustee Hall approved the Mayor's appointment of Mr. David Talley to represent the Town of Estancia on the EMWT Board. Trustee Lovato seconded the motion. All in favor. MOTION CARRIED
- 8.0 Schedule a hiring committee to conduct interviews for EMTs Action Item
  ACTION TAKEN: Trustee Lovato made a motion to schedule a hiring committee to interview EMT
  candidates on Thursday, March 2, 2023 here at Town Hall beginning at 6:00pm. Trustee Sedillo seconded
  the motion. All in favor. MOTION CARRIED

9.0 Executive Session- As per Motion and Roll Call Vote- Pursuant to NMSA 1978 10-15-1 Sections (H)(2)(8) personnel and the purchase, acquisition, or disposal of real property.

ACTION TAKEN: Trustee Hall made a motion to go into Executive Session- As per Motion and Roll Call Vote-Pursuant to NMSA 1978 10-15-1 Sections (H)(2)(8) to discuss personnel and the purchase, acquisition, or disposal of real property. Trustee Chavez seconded the motion. Roll Call Vote: Trustee Lovato- Yes, Trustee Sedillo- Yes, Trustee Chavez – For, Trustee Hall- Yes. MOTION CARRIED

Executive Session began at 7:32pm.

Reconvene Regular Session:

ACTION TAKEN: Trustee Sedillo made a motion to go back into Regular Session and stated that the only item discussed in Executive Session was the item listed on the agenda and no action was taken. Trustee Lovato seconded the motion. All in favor.

Regular Session resumed at 7:57pm.

Trustee Hall commented about the pond being too full. He is concerned about the trees dying near the

He said that he was approached by Mr. Andrew Gutierrez with the Chilili Land Grant and asked if the town would be willing to donate one of our older fire trucks. Mayor Dial will look into this.

Mayor Dial said that he was happy to report that the town broke ground on the new Animal Shelter behind the P&Z office.
