The Board reviewed the current FY23 budget and discussed the new FY24 budget. Salary increases were discussed. Trustee Sedillo requested more information from Clerk Jones and Chief Downing pertaining to the proposed increases. He would like to see proposed scenarios in incremental dollar increases, as opposed to percent increases. He made the point that a 3% increase, for example, is very different for someone making a lower hourly wage and someone making a higher hourly wage. He wants to be as fair as possible to every employee when considering these annual increases. Ms. Jones and Chief Downing will bring more information to the June 19th meeting to assist the Board in making these very important decisions. Clerk Jones commented that all of this meeting was very productive and informative and will assist her greatly as she builds the FY24 budget. She has submitted the Interim budget to DFA, but a lot more work will be done before the final budget is submitted. There will most likely be two more budget

workshops held in July before the final budget is reviewed and approved by the Board. The deadline to finalize and submit the final budget to DFA is July 31. NO ACTION, INFORMATION ONLY
