## TOWN OF ESTANCIA

PARTICIPATION IN LOCAL GOVERNMENT ROAD FUND PROGRAM AND REQUEST FOR MATCH WAIVER
ADMINISTERED
BY NEW MEXICO DEPARTMENT OF TRANSPORTATION

WHEREAS, the <u>Town of Estancia</u> and the New Mexico Department of Transportation enter into a Cooperative Agreement.

WHEREAS, the total cost of the project will be <u>\$66,667.00</u> to be funded in proportional share by the parties hereto as follows:

a. New Mexico Department of Transportation's share shall be 75% or \$50,000.00

and

b. The <u>Town of Estancia's</u> proportional matching share shall be 25% or <u>\$16.667.00</u> if Hardship for Match Waiver is not deemed to be present by Department of Finance and Administration and the Department of Transportation

## TOTAL PROJECT COST IS \$66,667.00

The <u>Town of Estancia</u> shall pay all costs, which exceed the total amount of \$66,667.00.

WHEREAS, the <u>Town of Estancia</u> has a limited tax base, which limits the funding for meeting the proportional matching share; and, a fund exists in the NMDOT appropriated by the New Mexico State Legislature for Public Entities in need of "hardship" match money and <u>the Town of Estancia</u> requests participation in this Match Waiver Program in the amount of <u>\$66,667.00</u>.

Now therefore, be it resolved in official session that <u>the Town of Estancia</u> determines, resolves, and orders as follows:

That the project for this Cooperative agreement is adopted and has a priority standing.

The agreement terminates on **December 31**, **2021** and the <u>Town of Estancia</u> incorporates all the agreements, covenants, and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, agreements and understandings have been merged into the written agreement.

NOW therefore, be it resolved by the <u>Town of Estancia</u> to enter into Cooperative Agreement Control Number <u>L500397</u> with the New Mexico Department of Transportation for LGRF Project for year 2020 - 2021 to <u>planning</u>, <u>design</u>, <u>drainage improvements</u>, <u>pavement rehabilitation/improvements</u>, <u>construction</u>, <u>reconstruction</u>, <u>sidewalk</u>, <u>resurfacing</u>, <u>construction management and miscellaneous improvements to Highland Avenue between NMSR 41 to the Senior Center</u> within the control of the <u>Town of Estancia</u> in <u>Torrance County</u>, New Mexico.


