DONOR DONATES AND RECIPIENT ACCEPTS THE GOODS "AS-IS" AND MAKES NO REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE GOODS HEREIN CONVEYED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AND ANY IMPLIED OR EXPRESS WARRANTY WITH RESPECT TO THE CONDITION OF THE PROPERTY OR ITS COMPLIANCE WITH GOVERNMENTAL LAWS, RULES AND REGULATIONS. RECIPIENT FURTHER RELEASES DONOR FROM ANY AND ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, TAXES OR ANY OTHER COSTS RELATING TO OR ARISING FROM THE OWNERSHIP, PICK UP OR USE OF SAID PROPERTY.

WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, RECIPIENT ASSUMES ALL RISK AND LIABILITY FOR THE RESULTS OBTAINED BY THE USE OF ANY GOODS. RECIPIENT SHALL INDEMNIFY, HOLD HARMLESS AND DEFEND DONOR AND ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS AND SUCCESORS AGAINS ANY AND ALL LOSSES AND/OR THIRD PARTY CLAIMS.

DONOR SHALL NOT BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, OR CONSEQUENTIAL DAMAGES ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT, INCLUDING BUT NOT LIMITED TO RECIPIENT'S USE OF THE GOODS, WHETHER BASED ON BREACH OF CONTRACT OR TORT (INCLUDING NEGLIGENCE).

This Agreement and all matters arising out of or relating to this Agreement shall be governed and construed in accordance with the laws of the State of Tennessee without giving effect to any choice of law or conflict of law provision or rule.

Title of the Goods passes to Recipient upon delivery of such Goods to the Recipient.

The Recipient will bear all costs related to this Agreement including but not limited to the transport, tax, and title transfer costs.

This Agreement constitutes the sole and entire agreement of the parties with respect to the Goods, and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to the subject matter.
